2. Minutes of last meetings (Actions carried forward)

- a. SM Competitions committee have incorporated weather check into Flow Chart for clubs.
- b. DK Action carried to present decanters to Wendy Chamberlain and Alex McNaughton
- c. All board reminded to review AGM minutes and report back if any errors or omissions in the next week
- d. JF and DK meeting with Highland Council to explore Highland Council support. This will not take place until after 5th March
- e. Paperwork for referees to be refined and ready for season starting back (LB advised there are still a few referees that were keen to have paper copies)
- f. BM met with Graham Cormack and was very encouraged by the operational plan and the delivery taking place from the Development Team. BM appreciated the

- a. DK provided update on CA response to COVID 19. Updates have also been circulated to member clubs and associations.
- Following a number of discussions with the finance committee and sportscotland expert resource at Harper Macleod it was confirmed by board on 31st March that 3 non-government funded staff members were to be furloughed

4. Finance KL

2020 Forecast

- a. KL provided an overview of CA Cashflow for 2020 and advised that the Camanachd Association have cashflow to cover the remainder of the year in spite of the COVID lockdown. The CA Staff have worked hard to access payment holiday where possible. To mitigate against major challenges moving forward we have furloughed three staff, applied for the government grant for small businesses.
- b. RM advised if the CA can generate a Recovery Plan they could submit to Common Good Funders for support.
- d. Membership RM and KL to prepare a letter for clubs with DK advising on Membership Payments and advising on financial circumstances. JF advised the future of our sport that our members are part of may be protected by membership contribution. LB advised that student payments if not already committed may be a challenge for clubs to recruit. SM suggested 50% of membership fee in the interim period would recognise the current situation and also support systems to be in place when things start back up. There was no objection to this suggestion.

5. Competitions

SM

- a. SM and RB confirmed that this years Senior Mens International and Mens u21 has been postponed to ensure club fixtures are prioritised for all members.
- SM advised that preparing a calendar of fixtures without clarity on a start date is challenging but that the preparation will prepare us for that time when it arrives.
 When there is clarity on a when sport may return further discussion will be required to finalise plans.
- c. SM advised it is important to understand how many weeks are available before a structure can be planned however it is a priority to deliver as many competitions as will be possible in the time available and maximising that time for all clubs will be central to the decisions made.

6. Equality Action Plan

- a. RB met with Graham Cormack and Chris Gibbons to discuss Equality Monitoring and bringing the CA up to intermediate level for the Equality Standard
